



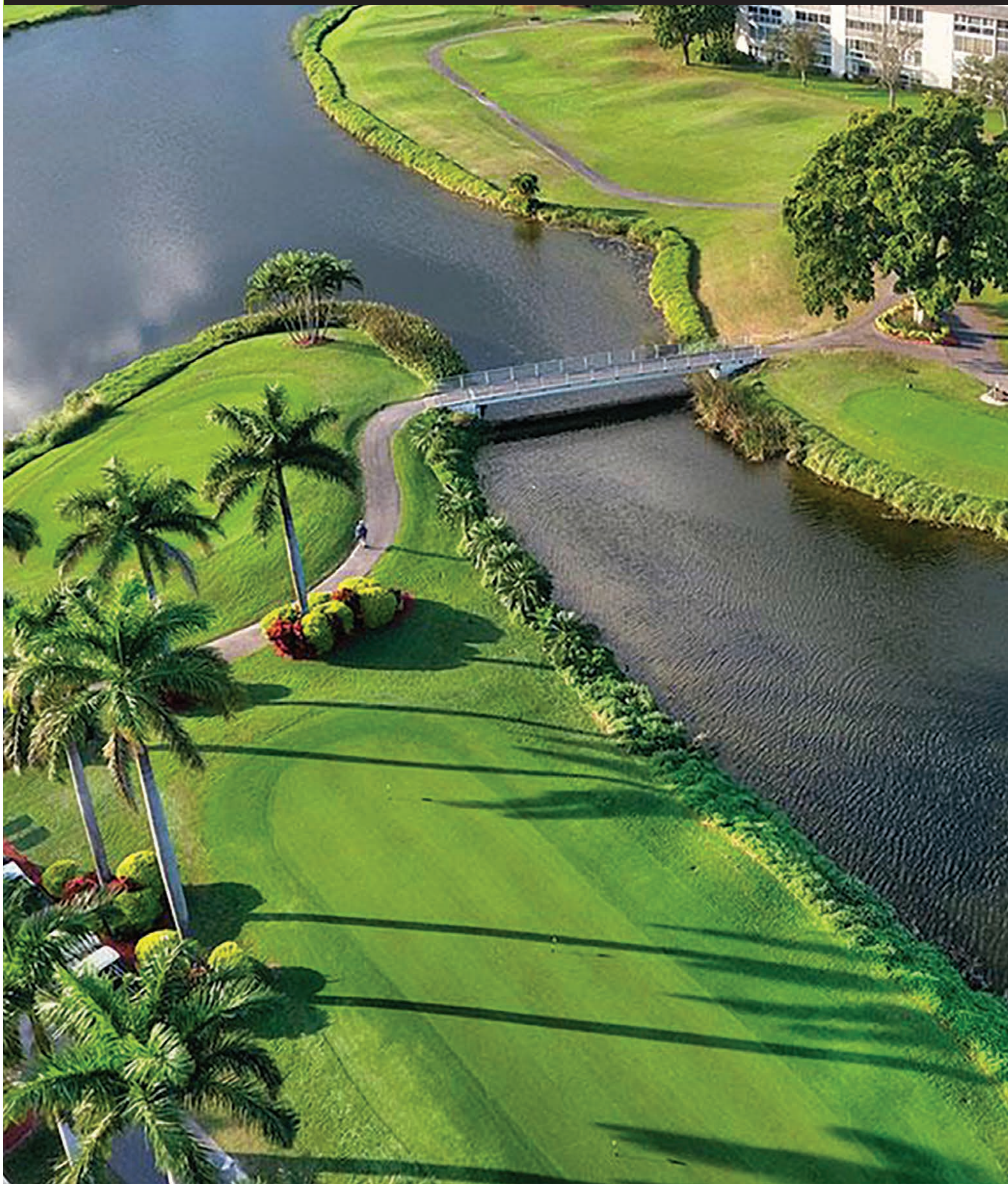

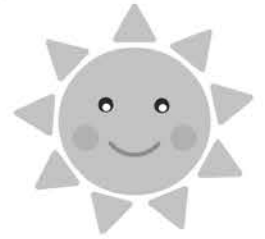

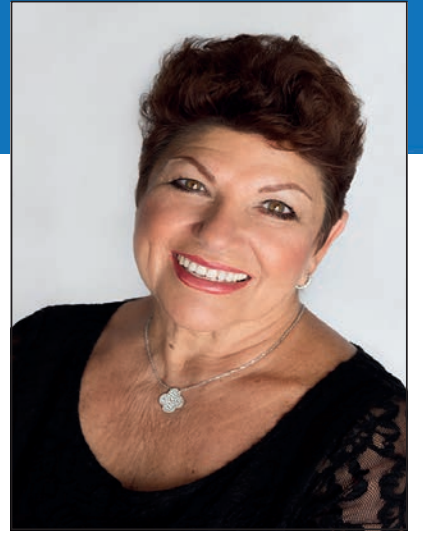

From the President



Welcome Summer!

As we step into the 2024 Hurricane Season, it's crucial to ensure your Hurricane Emergency Plan is both in place and up to date. Take this opportunity for a refresher course in Hurricane Preparedness. Stock up on essentials such as water, non-perishable food items, flashlights, batteries, a radio, and more. Once again, underlying the importance of having our plans in order before a storm looms on the horizon. Familiarize yourself with your options, stay prepared, and above all, stay safe!

The City of Coconut Creek will continue to advocate for the County Commission and the newly formed Solid Waste Disposal and Recyclable Materials Processing Authority to vote "NO." The priority should be to develop a master plan that includes waste reduction, recycling, and a disposal plan for the entire County for the next fifty years. They should not be considering an expansion to the Monarch Hill Landfill. Turnpike Expansion

There are several projects under design that all relate to Florida's Turnpike, the Sawgrass Expressway, and the interchange of the two roads. These projects are broken into several different projects, but all have concerning impacts on the City of Coconut Creek.

With regard to Turnpike, the project study for the mainline Turnpike is nearing completion and the City's concerns have not been addressed. The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise, held Public Hearings for the Turnpike expansion project for the section from Atlantic to Wiles Road. The project website, Turnpike595toWiles.com has transcripts for the hearings. Staff attended to voice the City's concerns, and many residents were also in attendance.

The City has major concerns that have been submitted to the Turnpike. Our concerns include: the Turnpike's insistence that the road project needs to shift to the west; the need for ten lanes when traffic volumes only warrant an 8-lane cross-section; the placement and height of the noise walls; and non-receipt of the amended plans from the Turnpike. The City will continue

to seek commitments from the Turnpike related to these important issues. Please continue to stay involved and share your concerns as we develop a plan of action.

Something For The Grandchildren

As the title implies, this article is meant for our grandchildren from thirteen (13) years old to whatever. I recommend you send this article to them and their parents. My goal is to let them know they don't have to have large sum of money (\$1,000, \$2,000, \$5,000 etc.) to start making reasonable returns on their money. I know one company where our grandchildren can buy Certificate of Deposits (CDs) as little as \$100.00 that matures in three, six or nine months - whichever they want. I will also describe how to select and safely invest in Mutual Funds (MF).

I am not a Certified Financial Planner, (CFP), but during the past four decades I have acquired enough knowledge on how to safely invest in CDs, Stocks and Mutual Funds (MF). No matter someone's profession it is imperative that he/she knows or acquire a basic knowledge about investment - at least know how and where to buy CDs and MFs without paying commissions or fees. Most people work hard for their money, the challenge is how to invest whatever they can afford safely. Time is money - money must not be left idle without earning interest, that is why banks and brokerage companies pay interest on cash balances in customers' accounts.

Where and How to Invest in Certificate of Deposits

Banks, Investment, and Brokerage Companies offer CDs to customers, but the minimum amount most require to open a CD account is one thousand (\$1,000.00) dollars. What happens if a grandchild has only two hundred (\$200.00) dollars to invest - where does he/she go? I recommend that he/she opens a brokerage account at Fidelity Investments, where anyone could buy CDs as low as \$100.00 that matures in three, six or nine months - you decide how long you want to invest your money. The minimum investment in CDs at Vanguard, TRowe Price, Citibank, Chase, and many other financial

institutions is one thousand (\$1,000.00) dollars.

If a grandchild is a minor, his/her parents or grandparents could open a Uniform Transfer to Minor Act "UTMA" account on behalf of that child. A UTMA account allows you or an appointed custodian to manage the minor's account until the latter is of age - eighteen (18) or twenty-one (21) depending on the state of residency. A very good lesson for any grandchild will be to watch and see one of the easiest ways to make money without any risk of losing a penny. That grandchild, depending on his/her age, could also learn how to calculate interest earned on CDs. As we all know, CDs offered by all financial institutions are insured by the Federal Deposits Insurance Corporation (FDIC) up to \$250,000.00 per customer.

I never worked for Fidelity, and they do not pay me to promote or advertise for that company. I opened my first Individual Retirement Account (IRA) about thirty-one years ago. Subsequently, I opened a brokerage account to invest mainly in CDs and MFs. For several years, I invited and encouraged members of my family, friends and acquaintances to use Fidelity - all of them are still very happy with that company. It is very easy to open a brokerage account with Fidelity at www.fidelity.com - no minimum required. Some companies require a minimum amount to open a brokerage account.

How to Select and Invest in Mutual Funds

Many companies offer MFs with excellent performances or returns for the past several years. To purchase MFs, you don't have to limit yourself to Fidelity - there are thousands of MFs offered by many companies to pick from. I will now describe how to select MFs to invest your money.

You don't need a college degree on how to select MF to invest your money. I always use this short story and question to explain how to select mutual funds. If you must select a student from three students with "A", "B", or

"C" average grade - which student will you select? Most people will select the student with "A" average grades - that is what I would do. Something drastic must happen to that "A" student to become a "C" average student. From an investment point of view, even if a MF with an "A" average return drops to "B" average return, you will still be satisfied with your return or gain and still be "laughing to the bank."

To select a MF, you can also compare the year-to-date, previous three, five, and ten-years performances or returns of a few mutual funds before you select those to invest in. Obviously, you would select mutual funds with highest previous years returns. I considered investment in MFs a long-term investment - that is five or more years.

I recommend you select MFs in these industries: Technology, Energy, Pharmaceutical, Consumer Products, Semiconductors, and Insurance. If you are a lucky grandchild, and your grandparents leave you a large sum of money, I recommend you contact a CFP at a big bank or investment company to manage your investment portfolio.

May you be as financially rich as you desire.

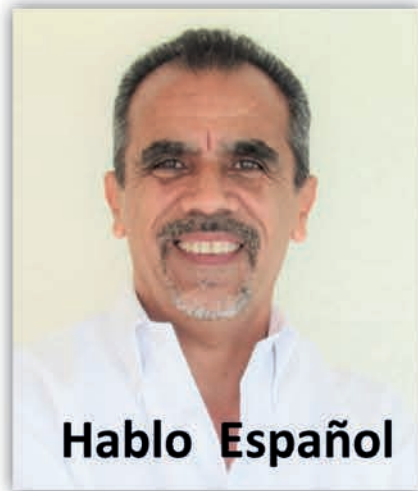

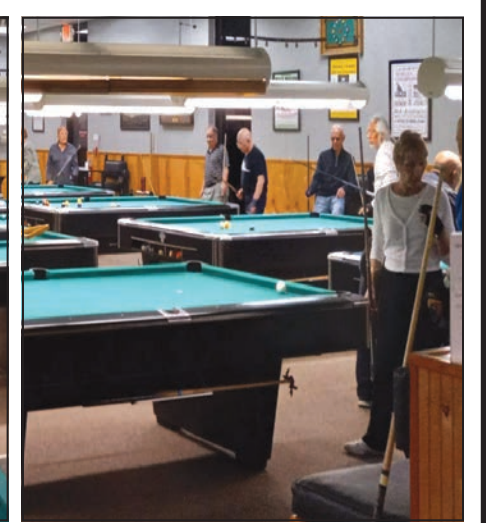

ASK DR. JOY

Withdrawal or Renewal?

I was asked a question a while back about whether being alone a lot constitutes being depressed. I didn't have a lot of information and didn't know who submitted the inquiry so here's my answer as best as possible under the circumstances.

Not really knowing how you feel it is somewhat difficult to answer you directly so I'll do a few different scenarios. If a person is depressed and staying home and alone for days on end without

having any personal contact, this is something that needs to be addressed professionally. Especially if the person is not eating well, not showering, and/or sleeping a great deal. This is obviously symptomatic of emotional decline or trauma.

If this is the case with you or anyone you know, please do not hesitate to let your primary care physician know so a mental health professional can be brought in. Medication may be appropriate but this would be after an evaluation by a clinical psychologist or psychiatrist. Only the psychiatrist who is an M.D. can prescribe medication but it can be at the suggestion of the psychologist.

If this is not the situation, let's look at others. There are times when you just don't want to deal with the negativity or intrusiveness of others and find yourself withdrawing from contact. The issue here would be how often and for how long. If you enjoy your home and your own company and find it peaceful and relaxing that's great. If you have things to do alone that are enjoyable to you and you get real pleasure from this, once again no problem at all. If you do this part of your day or a few days a week while seeing other people at other times and find yourself having a good time with them, this is the perfect balance for you. Everyone is different. Sometimes it's problematic when you are alone all the time and on the other hand some people cannot be alone at all at that is just as problematic. A frantic obsession with needing people to eat every meal with or go shopping or having to be busy constantly with others says quite a lot about a fear of being alone. Once again, everyone has different needs and enjoyments. If you are withdrawing from people who at one time gave you pleasure and you enjoyed their company what changed for you? This



is an important piece of information to evaluate why you are isolating.

You mentioned that your children think you are alone too much. Have you asked them why they think this? Perhaps they think you aren't feeling well and that's why you are not as busy. Remember they have known you all their lives and they may be seeing changes in you that concern them. Have you told them you are tired of people's negativity or problems and want to avoid listening to them or speaking about them? They would probably understand that as they most likely have people like that in their own lives. I know I was so busy when I was younger between work, family, home, travel, entertainment, etc. that it was easier to avoid unpleasant people. But what about pleasant people? If they are being avoided, that's a larger issue.

I see that my own daughters seem to feel better when they think I am busy and engaged. Even if I spend a lot of time alone (which I do), they know I am writing an article or another book or reading or watching something I really enjoy on TV and that I still see people at some point most days: go out for a meal, play Mah Jongg, take classes and lead others etc. Let your children know you are enjoying your time alone and on the lookout for more positive, interesting people to spend your time with. Only you know if there is more to your being alone than you have said. Maybe you do feel fatigued or lethargic and just can't seem to get yourself going. Maybe when people discuss their problems with you, you are too empathic and take it on yourself and this is draining. There is a difference in being compassionate and being empathic. Compassion is feeling for another person while empathy is taking it on yourself and actually feeling their pain (or pleasure, but that's pretty good). You don't want to take on someone else's pain and if the only way you can avoid doing this is to withdraw, then that is a great solution. Being a compassionate, caring person is different as long as you remember you don't have to fix anything for them and that your being there is enough. But if you find yourself taking on their burden, then that is your cue to leave, be alone and re-group.

If happy people are sharing good news with you, do you partake? What are you feeling under those conditions? As you can see, I'm attempting to ascertain what your withdrawal is due to.

I think what made me a good therapist during my working years was my ability to not collapse into the client's pain. Only by keeping my boundaries and perspective was I able to be of assistance to them.

There is quite a bit of information here so take from it what you find helpful and leave the rest. If you have a follow-up question, I would be happy to address it.

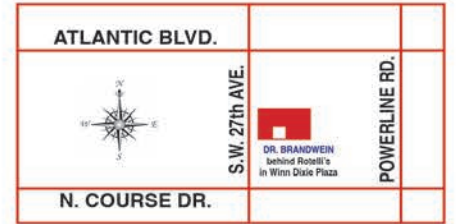

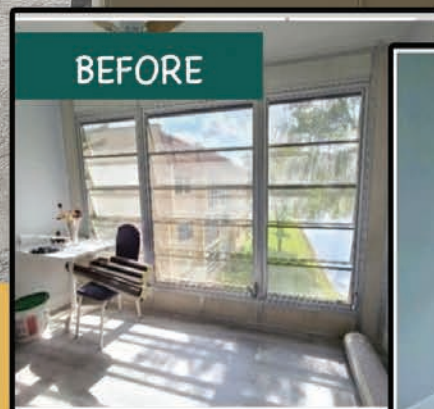

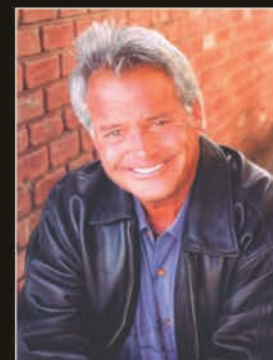

Avoid Probate on Your Home

There are several ways to avoid probate on your home when you die. If you are single, there will be probate when you die unless you choose one of the following options. If you are married and own your home together, your surviving spouse will not have probate; however, there will be probate when the second of you passes away, unless one of these options is done.

Let us assume that you own your home jointly with your spouse and that you have two children. Both of you desire to have your two children inherit your home equally when you both pass away.

The first option would be to add the names of your two children to the Deed as joint tenants with right of survivorship. This is not a good idea. It would affect your ability to claim your full homestead exemption. In addition, you lose control of your property and can only sell it if your children both agree and sign all closing documents. If you wanted to take one of the children off the Deed, you would be unable to do so. If one of your children files for bankruptcy, has an adverse judgment or files for divorce, your property could be subject to liens or other legal action. Therefore, I recommend against a Deed with your children as joint tenants with right of survivorship.

The second option is a Life Estate Deed. There are two types of Life Estate Deed: regular and Enhanced (also referred to as Lady Bird). Both designate your children as having the residuary interest when you both die. The regular Life Estate Deed requires that your children join in any sale or other changes on the Deed; therefore, you have lost control and cannot take your children's name off the Deed if you choose to do so. The Enhanced Life Estate Deed gives you the sole right to sell the property during your lifetime or make any other changes to the Deed without the permission of your children. The



Enhanced Life Estate Deed has very specific legal language in order to be effective; therefore, do not attempt to do this on your own.

Even with the Enhanced Life Estate Deed, there are risks, particularly if your child has a bankruptcy, outstanding judgment or undergoes divorce. The worst risk, however, is if, God forbid, your children die with you in a common accident. There would then need to be probate for your children and for you.

The best way to avoid probate on your home is to do a Revocable Living Trust. When you sign the Revocable Living Trust Agreement, you also

sign a Deed transferring the property to you as Trustees of your Trust. You are able to keep your homestead exemption, maintain complete control of the property during your lifetime and make amendments to your Trust without changing the Deed. There are no risks involved, since your children's names do not appear on the Deed. The only disadvantage of the Revocable Living Trust is that it will cost more money in attorney's fees. When you discuss the options with your attorney, you should discuss the difference in fees between the Revocable Living Trust and the Enhanced Life Estate Deed. You can then determine whether it is worth saving the money and taking the risks involved in the Enhanced Life Estate Deed.

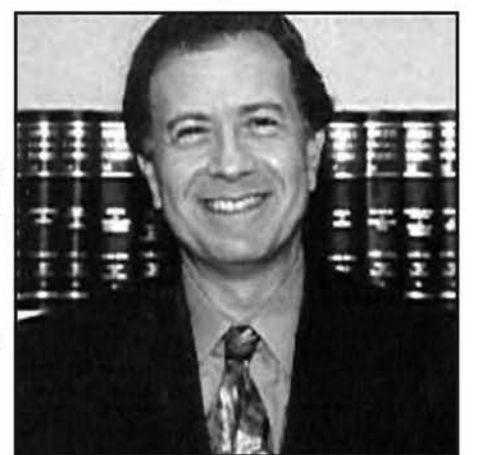

Don't Let Investments Take A Vacation

Don't compare your portfolio's results against those of a market index, such as the S&P 500, which tracks the stock performance of 500 large U.S. companies listed on American stock exchanges. So, instead of checking your progress against a market index, use benchmarks meaningful to your individual situation, such as whether your portfolio is showing enough growth potential based on a compounding rate of return to keep you moving toward a comfortable retirement and other long-term goals.

- *Invest with a purpose.* When you work intensely at something, it's usually because you have a definite result in mind. And this sense of purpose applies to investing, too. If you buy a stock here, and another one there, based on “hot” tips you might have seen on television or the internet, you may end up with a jumbled sort of portfolio that doesn't really reflect your needs. Instead, try to follow a long-term investment strategy based on your financial goals, risk tolerance, asset accumulation needs, liquidity and time horizon, always

with an eye toward where you want to go in life — how long you plan to work, what sort of retirement lifestyle you envision, and so on.

- *Be strategic with your investments.* Over the years, you will likely have a variety of competing financial goals — and you'll want your investment portfolio working to help achieve all of them. That means, though, that you'll likely need to match certain investments with specific goals. For example, when you contribute to an IRA and a 401(k) or similar plan, you're putting away money for retirement. But if you want to help your children go to college or receive some other type of post-secondary education or training, you might want to save in a 529 education savings plan, which allows tax-free withdrawals for qualified education expenses. Or, if you want to save for a short-term goal, such as a wedding or a long vacation, you might choose an investment that offers significant protection of principal, so the money will be available when you need it. Ultimately, this type of goals-based investing can help ensure your portfolio is always working on your behalf, in the way you intended.

As luck would have it, I was playing terribly and at one point she bent down and removed my ball from the cup. She proceeded to inspect the ball and called my attention saying, "Look, this ball is dirty and all scuffed up." She went on to say, "You should not be trying to play this ball!" Susan reached into her pocket and withdrew a shiny new ball saying, "Here, you play this ball!" I replied that my golf balls were fine and it wasn't likely that I'd hit any ball all that well. However, I thought that I noticed Susan's game was something less than I might have expected.

Later my wife and I would meet Susan's husband Paul as they would become our partners for the "Guys & Dolls" tournament played here at Wynmoor. This is played with everyone hitting a ball and the best shot chosen to play from for the next shot. Paul was very sick and weak when we met and could do little more than ride around in the golf cart and occasionally putt a ball on the green. When Paul would try to putt I would always take his hand and help him to the green. When he was through I would lead him back to his golf cart. Despite it all, Paul was a good putter, sinking several difficult putts. On occasion we would hit an extra ball for him if the others came out bad.

Susan seemed always concerned that each of us had a chance to be part of the play. She would recommend an inferior lie so that either Linda or I had our ball played. Our team would finish somewhere in the middle of the group, then go in for lunch. We always sat together and Susan would help Paul with his food. Occasionally one of us would win a prize for hitting our ball onto a green.

Things were very different the last tournament that we played. Paul was much sicker and was not at the tournament. Susan basically said nothing about it and a couple of times when we came up short on the green I said to Susan how much we missed Paul and that we sure needed him.

Susan was playing like a tigress from the get-go. I could see that she was holding nothing back. Time and time again she ripped that ball off the tee straight down the center of the fairway. Her second shots soared high, finding their way to the green leaving easy putts for a clean par.

We finished with an even par putting us in a tie for first place. After lunch we said our goodbyes and went about our business. It was later that week that Linda and I found out that Paul had died. A memorial service was planned for here in Florida the following Sunday. Susan and Paul are of the Buddhist faith so this would be something new for us.

After arriving at the memorial service, Linda and I were seated in the front row, and there were many familiar faces. The place was packed. An emcee basically ran the show with his own discussion and remembrances along with the aid of a video screen and computer. In between his talks the screen showed various pictures of Paul and his family at past times. Some of the pictures were in normal clothes while others were elegant clothes reflecting his heritage. Behind this of course there was music appropriate for the occasion. These short vignettes were spaced between spoken dialogue about Paul's life.

Suddenly, as I was watching the screen and music was playing, there I was on the screen holding Paul's hand, helping him into the golf game! I was without words! My eyes were soaking wet! How had I made such an impression on this family by such a simple act? I just sat there staring at the screen for the short few seconds that the picture was there. Paul had come into my life as a speck of dust might getting caught in my eye, then pausing for a short time only to be washed away with a tear. I will never forget him.

Air Fryer Salmon Bites

These quick and easy Air Fryer Salmon Bites are full of flavor and cook in just 6 minutes! They're tender on the inside, crispy on the outside, and glazed with a sweet and savory marinade. Enjoy them with appetizers, dinner, or meal prep!

Prep Time 10 minutes minutes
Cook Time 6 minutes minutes
Marinade Time 30 minutes minutes
Total Time 43 minutes minutes
Servings 4 people

Ingredients:

- 1 lb salmon skin removed
- 1 Tablespoon sesame oil
- ¼ cup soy sauce or coconut aminos
- ½ Tablespoon honey
- 2 cloves fresh garlic minced
- 1 teaspoon apple cider vinegar
- Green onions for garnish



Instructions:

- Using a sharp knife, cut the salmon filet into one-inch cube.
- In a glass bowl, add sesame oil, soy sauce, honey, garlic and apple cider vinegar. Whisk together until smooth. Set aside 2 tablespoons of marinade to use for brushing the salmon while it cooks.
- Add the salmon bites to the marinade sauce and place in the fridge to about 30 minutes or up to 2 hours.
- Place marinated salmon bites in the air fryer basket in a single layer and cook for 3 minutes at 400°F.
- Open the air fryer and brush the reserved glaze on the salmon bites. Close the basket and cook for an additional 3 minutes.
- Serve it with rice and steamed broccoli. Enjoy!

Notes:

- You may need to air fry the salmon in batches, depending on the size of your air fryer. It's important not to overcrowd the basket.
- For easy cleanup, you can line your air fryer basket with parchment paper.

Acupuncture and Postherpetic Neuralgia

If you've ever had the misfortune of experiencing shingles, you know how horribly painful and debilitating it can be. This inflammatory condition is caused by the same herpes virus that causes childhood chicken pox. The virus remains dormant in

the body after infection and can awaken at any time later in life, attacking the spinal nerve roots. The risk also rises if something down-regulates the body's immune system, such as chemotherapy medicines to treat cancer.

Many patients continue to suffer for months or even years after the initial outbreak has cleared. This is known as postherpetic neuralgia. The risk of postherpetic neuralgia rises with age as it mainly affects people older than 60 and those with pre-existing conditions such as diabetes, fibromyalgia, or other viral infections. There is no known cure, but treatments can ease symptoms.

The symptoms of postherpetic neuralgia are most-often limited to the area of skin where the shingles outbreak first happened. This is commonly in a band around the trunk of the body, most often on one side. If the patient's initial outbreak also attacked the head, face, and eyes, then these areas are also susceptible to ongoing inflammation.

The symptoms might include:

1. Pain that lasts three months or longer after the shingles rash has healed. The pain may feel burning, sharp, and jabbing. Or it may feel deep and aching.

2. Not being able to stand light touch, even the touch of clothing on the affected skin.

3. Itching or loss of feeling. Less often, postherpetic neuralgia can cause an itchy feeling or numbness.

4. Depression, insomnia, fatigue, loss of appetite.

Western medicine treatments include antidepressants, antiepileptics (gabapentin and pregabalin), opioids (oxycodone, morphine, and methadone), and topical agents, such as lidocaine plasters and topical capsaicin as well as spinal nerve blocks. However, these therapies are often accompanied by serious side effects, and their efficacy is limited.

Acupuncture treatment for post herpetic neuralgia offers several advantages over traditional western approaches and often provides relief when other approaches have failed:

1. Other than an overall sense of relaxation and calm, there are no side-effects.

2. Rapid reduction in pain symptoms, often after only one or two treatments.

3. With ongoing treatment, improvement in depression, insomnia, and fatigue with the ability to reduce or discontinue the use of medications that have been prescribed for this condition.

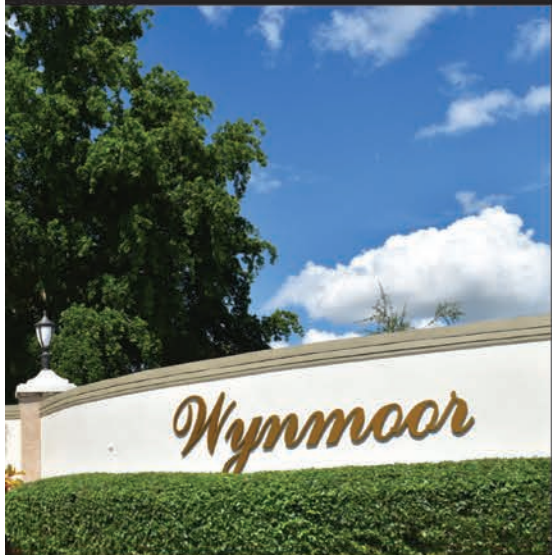

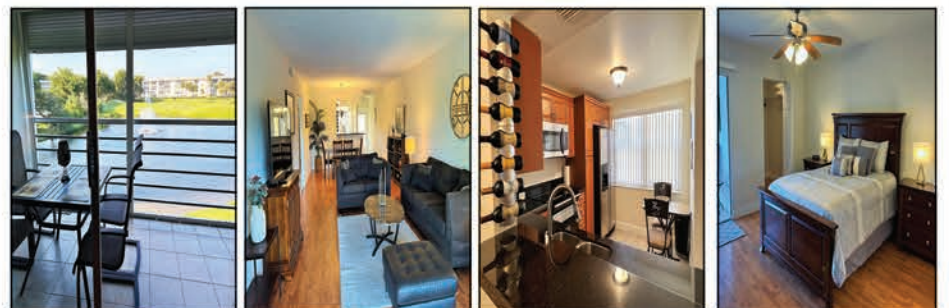

The Liberal Jewish Temple

Ah, June. And here comes a favorite holiday - Shavout, The feast of Weeks. This year it is celebrated from sundown on June 11th to sundown on June 12th (Reform) and June 13th (Conservative and Orthodox). Reform Congregations hold Confirmation Services for 16-year olds who were thought to be too young to fully commit to Judaism at Bar or Bat Mitzvah at 13. This is generally the time of the wheat harvest in Israel and the Book of Ruth is read. Many Jews eat dairy products, but the origin of this tradition is hazy.

Did you know that the island of Jamaica was once home to more than 22,000 Jews? Today, most Jews live in the capital of Kingston. The approximately 500 Jews who live in Jamaica today come from all over the world, but mostly from Poland, France, Italy, Africa, Israel, and Turkey. Like Jews in other parts of the world who have adapted local customs to their own ways of living and practice, the Jews of Jamaica have their own recipes for Jamaican dishes, which include ackee, saltfish, fried bammy, breadfruit, potato pudding, dukono pastry and jerk chicken. The synagogue has a dirt floor such as seen in other synagogues in the Caribbean.

Some Jamaican Jews trace their origins to Portugal, where their ancestors were forcibly converted to Catholicism by King Manuel the first in 1497. They could not legally emigrate but still found ways to leave, moving to Spanish Portuguese communities in Germany, England, Italy, and Amsterdam. For the next decade some of these conversos went from Amsterdam to the Caribbean, including Jamaica. They settled in many towns throughout the island. Jamaica was a Spanish colony, but because it was controlled by Christopher Columbus' family, the inquisition could not establish a base on the island. To practice Judaism was illegal, but people were not persecuted.

The British colonized Jamaica in 1655. Under the British, it became legal to practice Judaism. The island's first synagogue was established in Port Royal, which was a bustling commercial community. The oldest Jewish burial ground in Jamaica is just across the Bay from Port Royal in Hunts Bay cemetery. The skull and crossbones appear on 7 graves. And yes, there were Jewish pirates.

One of the most famous of the pirates was Moses Cohen Henriques, who would steal shipments of gold and silver from Spanish boats off the coast

of Cuba. Henriques had his own pirate island off the coast of Brazil and worked with captain Henry Morgan in Jamaica after 1654.

The Jewish community of Jamaica reached its peak in the late 18th and early 19th centuries. Under British rule, the Jews flourished by selling sugar, vanilla, tobacco, gold, rum, and other products. By the early 20th century many Jamaican Jews had emigrated to the United States, England, and Australia. The high point of Jewish population was in 1881.

There was only one synagogue in Jamaica from 1921 until 2014 when Chabad opened a center in Montego Bay. Sharre Shalom, in Kingston has 13 Torah scrolls in the ark, many from previously active congregations.

Rastafarianism, a religion developed in Jamaica in the 1930s. and was popularized by Bob Marley and his reggae music, uses many Jewish symbols and themes. Many Rastafarians focus on the Hebrew Bible, particularly the themes of freedom and justice. They also believe that the Ethiopian emperor Haile Selassie was the Messiah because he was a descendant of king Solomon. Rastafarians use the symbols of the Star of David and the Lion of Judah.

Many Jews were prominent in Jamaican government after Jamaica became independent from Britain in 1962. However, in the 1970s, some Jews left for political reasons. When Edward Sega was elected in 1980 some of these emigrants returned. Today, the Jewish community is small but highly active.

If you wish to learn more about Jews in the Caribbean, especially pirates, please read Edward Kritzer's book, "Jewish Pirates of the Caribbean," published in 2008.

2024 Estimate of Taxable Values

The preliminary 2024 property values are now showing on our website at web.bcpa.net. Florida Statutes require our office use January 1st as the date of assessment each year. Our office must consider changes in market conditions – up or down – when developing the Just/Market Values each year. The 2024 Just Values are based on the market data from January 1, 2024 *back through* January 2, 2023 with January 1, 2024 as the date of assessment. If you purchased your property in 2024, your 2024 purchase price along with comparable market data from 2024 will be used in setting your property's 2025 Just/Market Value. Our office will mail the 2024 TRIM (proposed tax) Notices to all Broward property owners in mid-August. This notice will show your property's 2024 Just Value, Assessed/Save Our Homes Value, all tax-saving exemptions you are receiving, and the proposed tax rates as set by the various taxing authorities listed on the notice.

Quarterly Tax Payment Installment Plan

While the Property Appraiser's Office does not set or collect taxes, our office receives many calls from residents inquiring about installment tax

bills and their recently approved exemptions. Broward County's Records, Taxes & Treasury Division is responsible for the billing and collecting of property taxes.

For property owners on the 2024 installment payment plan, the first two installment payments (June 2024 and September 2024) are based on the previous (2023) tax year. This means residents who have been approved for 2024 Homestead Exemption or other exemptions will not see these 2024 exemptions on either the June or September installment bills. The final two installment bills (December 2024 and March 2025) will be adjusted to include any 2024 exemptions or changes to the property's taxable value. The deadline to apply for Broward County's Installment Payment Plan was May 1, 2024. In early April, I visited the Denver Art Museum located in Mile High Denver, Colorado. The Denver Art Museum’s collection of Art is very multifarious. This review is dedicated to its fine collection of 19th Century European Paintings located in the aesthetically appealing Hamilton Building designed by Daniel Liebeskind.

French Painters with captivating paintings on display included; Marguerite Gerard “The Hussar and His Family,” done in the Rococo Style, Jean Leon Gerome “Collaboration,” fine depiction of 2 French Playwrights, Moliere and Corneille, William Adolphe Bougureau “Childhood Idyll,” French Romantic theme, Jean Millet “2 Figures in Landscape,” French Romantic, Jules Breton “Haymaker,” the epitome of French Romanticism, Gustave Dore “Family of Street Acrobats,” sombre Realism, Camille Corot “Villa Avray, Pathway in Pond,” fine Pre-Impressionism, Gustave Courbet “Landscape With Twin Trees,” Charles Daubigny “River Landscape,” Barbizon School, Henri Harpignies “River Scene,” Eugene Isabey “Untitled,” wonderful depiction of Boats, Antoine Vollon “View of Antwerp,” and Eugene Boudin “Pasture in Normandy.”

I also savored fine British Paintings in this section of the Denver Art Museum by John Constable “Yarmouth Pier,” Edward Lear “Nuneham,” and Thomas Jones “View of River Nye.” A fine recent addition to the Denver Art Museum is Belgian Painter, Albrecht de Vriendt’s Oriental theme work, “Lisa, Bride of Bethlehem.”

Hopefully, if you visit Denver and the state of Colorado, you will enjoy the Denver Art museum as much as I have.

Hurricane Preparedness Should Never Be Ignored



Hurricane season runs from June 1st through the end of November.

Typically, the tropics are quiet through much of the late spring and early summer, with peak hurricane season coming around Labor Day. We talk a lot in emergency preparedness about hurricane kits.

Hurricane kits should include, especially if you're going to stick around after the storm, all of these items:

- 1) Enough water to last you, and every member of your household, at least a week. A gallon a day per person is what many recommend.
- 2) Food. Assuming power will be out, make it non-perishable. Cereal. Crackers. Peanut Butter. Canned fruits and vegetables. These are just to name a few options.
- 3) Flashlights and batteries. We don't recommend candles because if left unattended it can become a fire hazard.
- 4) Make sure and have all your important papers with you, such as insurance cards, driver's license, homeowners' or renters' insurance documents, etc.
- 5) Have all your medications with you, especially if you have to go to a shelter.
- 6) Cash. If there are widespread power outages, merchants won't be able to take bank or credit cards.
- 7) Don't wait until the day the storm is supposed to hit to put all this stuff

together, do it now.

Coconut Creek has been hurricane-free since Irma in mid-September, 2017. While we have been in "the cone of concern" a few times since, a named storm hasn't really threatened us. So, since we live in South Florida, have we just gotten lucky the past few years? Or are we due for another one soon? Your guess is as good as mine. The bottom line is that you need to be prepared and get those hurricane kits ready.

The city has its hurricane preparedness plan always ready to go. The city's emergency operations center is in the 4900 building on the City Hall campus. It is in constant contact with state and county-level emergency operators before, during, and after a storm. The city will issue all pertinent warnings and safety information in a variety of different ways to make sure you stay informed.

Training With Purpose

- A defensive tactics room that will allow our first responders to train in hands-on techniques to help de-escalate potential use of force incidents.

- EMS and simulation labs, which will enhance the readiness and medical skills of our firefighter/paramedics for emergency response.

- A rappelling wall for our fire rescue personnel, preparing them for structural fires or multi-story building rescues.

- A 22,000-square-foot strength and conditioning facility dedicated to keeping our employees' mental and physical health at its peak. My goal is to introduce comprehensive fitness programs to meet the needs of everyone at BSO.

- Three large configurable classrooms to accommodate our employees' ongoing educational and professional development.

While the RDTC represents innovation and progress, our mission remains steadfast: the safety and well-being of the entire Broward County community. As sheriff, I am committed to introducing new and innovative programs and initiatives focused on upholding the highest standards of excellence in public safety.

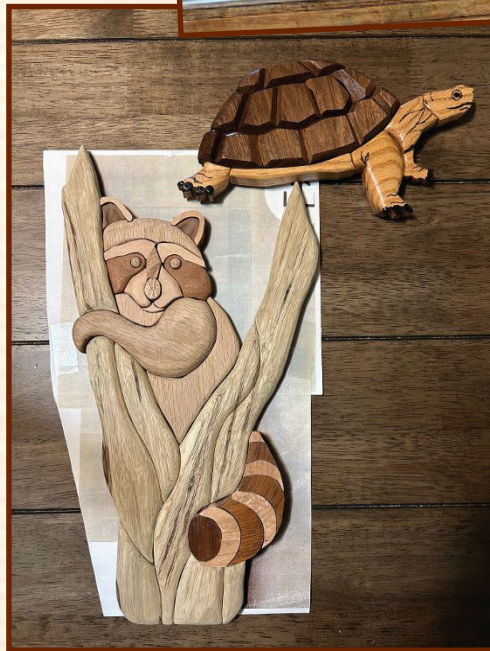


WOODSHOP

The Woodshop is constantly replenishing the two display windows outside the Shop doors with new and exciting pieces of art produced by our members. Feel free to come in and look around and ask questions. The shop does repair work on almost anything "If it's wood, we could." Unfortunately, the repair work has to be done in shop only. Almost all repairs are completed overnight or within 2 days.

This month's first three photo offerings are from our newest red badge members. Izzy Kutnowski has made giant strides in just 2 months. Photo in the middle is a religious book holder and 3 wood tubes, 1 for flowers and the other 2 are to house a religious scroll called a Megillah, the Biblical story of Esther. Last, 2 serving trays and slim line acrylic ink pens for Izzy's daughter and wife. Larry Mintz presents his smooth edge cutting board crafted from maple, Venezuelan padauk, ash, and black cherry. Larry has also mastered the lathe and now is turning out pens such as these. Alexia presents the completed project from Steve Gleimer's Intarsia class featuring a hard-shell tortoise and a racoon up a tree made with 85 individual pieces that all have to be individually shaped.



Everett Yankee is showing off his tiger maple jewelry box with floral inlay, 5 felt drawers and gold accouterments! Shel Geller designed these two chess boards for his grandchildren. Shel incorporated Central American rainbow padauk and African Wenge to produce this stunning sunset appearance. Shel now moves from the table saw to the lathe and created two tall vases of walnut, oak, padauk and black limba. Finally, an eye-catching Baltic Birch plywood vessel perched atop a black walnut pedestal.

Here we have Ernie's shallow 18" "dish" tooled from Malaysian Maurita, (rubber tree) and assorted colorful hardwoods. It is all cut straight grain (side grain) and finished with water-base gloss urethane.

The selected items in this last photo were produced from Jerusalem Olive Wood. This species has a twisty irregular grain, is uncooperative during cutting, tends to warp, but produces a lustre that is unsurpassed in the industry. It is not unusual for lumber of this species to be 1000 years old. Current per board foot cost for items created in this photo is \$140/Bf. Olive wood tells you what to do to it, you don't tell it!
