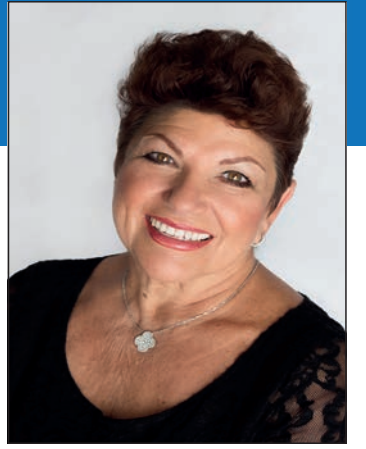

From the President



On a personal note, I wanted to let you know that the 14 counts filed against me with the State of Florida Ethics Commission have all been dismissed. This experience has been a powerful reminder that you can't always believe what people say until all the facts come to light. I'm sharing this because if you ever find yourself in a similar situation, it's vital to stand up for yourself and trust that the truth will surface. Let the facts speak for themselves. Always believe in your integrity, and no matter what challenges or accusations come your way, remember that the truth will protect you. Your support and encouragement has been overwhelming. Thank you!

The future success of Wynmoor is dependent upon many things. Most of us are unaware of the "inner workings" and the system upon which the community was set up. It is safe to say that our founding fathers came up with a rather unique "government", one upon which Wynmoor has thrived and has been able to achieve and maintain a status of excellence throughout South Florida and beyond. Many communities have looked to us for guidance and advice on a few significant issues over the years and we have proudly collaborated with them to resolve their concerns.

All of us live in "associations." Each of the 44 association have a board of directors who are responsible for the good and welfare of the individual association. They are the governing body; they participate in the budget process, they review and approve contracts, they assist in unit owner issues, and they disperse information to their constituents.

Then we have "Wynmoor Community Council." The Council's basic function is to oversee and ensure the successful operation of the facilities; this includes all common property that is not owned by an individual association. Each association has a Council Representative that sits on the Council Board of Directors and participates in the decision-making process on behalf of their association. All "directors" have a fiduciary responsibility to their constituents and are expected to perform with honesty and integrity and assure their residents of representation at all meetings.

The Management Committee is chaired by the President of Council and consists of (4) Vice Presidents. The Council has an Executive Committee which submits its findings and recommendations to the Council Board of Directors. The Executive Committee is composed of the Officers of the Council Board of Directors and one elected representative from each Village; Andros, Antigua I, Antigua II, Aruba, Bahama, Bermuda, Bimini, Cayman, Eleuthera, Granada, Lucaya I, Lucaya II, Martinique, Nassau, Portofino I, Portofino II, and Victoria.

The Budget and Finance Committee consists of all Council Officers plus at least (5) duly appointed unit owners. The Committee reviews the monthly financial operations of Wynmoor Community Council and the Annual Budget. Other standing

committees include Architectural, By-Laws, Hearing, and Long-Range Planning. The President shall appoint the Chairperson and members of the standing committees. They may find it useful to conduct hearings and report on policy questions, evaluate operations and submit recommendations.

We are grateful for each committee member's willingness to give their time, energy, expertise, and talents. Their support of Wynmoor allows us to continue to fulfill our mission in our community.

Don't forget to go out and vote on Tuesday, November 5, 2024! It's your chance to make your voice heard. Whether it's for your local representatives or the national elections, every vote plays a crucial role in shaping the future. Make sure you are part of the decision!

We are deeply grateful to our veterans, for they are the reason we enjoy the freedoms and privileges we have in the USA. Many of us have had family, friends, teachers, who have selflessly served, granting us the ability to live in peace and security. Let's take the time to thank these amazing veterans for their service, not just today but throughout the year. Their sacrifices deserve our continual recognition and appreciation.

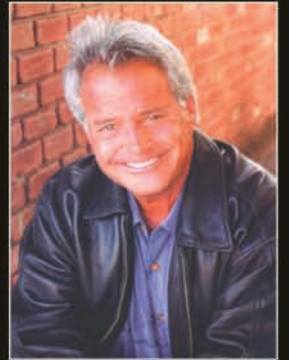

Latest Scam Alerts Show We Still Have Room To Improve



We issue scam alerts on our social media pages, and on our website, www.coconutcreek.net/pd. We put out several during the month of September and I want to share them with you here in case you missed them:

Cable Company Scam:

The Cable Company Scam rears its ugly head again in this Coconut Creek Police Department Scam Alert. A Coconut Creek man recently called us after finding several unauthorized withdrawals from his bank account. It turned out that someone posing as a representative from his cable company, Comcast, called him a few days before and told him he was behind paying his bill. Of course he really wasn't. The scammer threatened to cut off his cable if he didn't pay right then and there so the man gave him some of his personal information. The scammers used it to get into his bank account and make those withdrawals. Remember that the cable company, or your water/sewer provider, or any utility company for that matter will never call you on the phone and demand payment for a delinquent bill. They'll always send you written notice first. If you ever get a similar phone call, just hang up.

Apple MacBook Repair Scam:

The Apple MacBook Scam is the basis for this Coconut Creek Police Department Scam Alert. Recently a man called us to report that he was on

his MacBook and started having issues with it. He decided to do a Google search for help and called the first number that popped up. That was a mistake because he called a scam artist. The fraudster talked the man into letting him remote in to his computer and then stole a bunch of money from his bank account. The big lesson here is to never trust any phone numbers you find online. We recommend finding a local computer repair shop and taking it there.

Crypto Investment Scam:

Crypto Investors, Beware is the theme for this Coconut Creek Police Department Scam Alert. A Coconut Creek man recently lost a significant amount of money in a phony crypto wallet scheme. The scammers initially contacted him through LinkedIn, manipulating the results of his first investments to lure him into investing more money. The returns seemed too good to be true—and they were.

Always do your homework before investing your hard-earned money. Remember, if something seems "too good to be true," it probably is. And never trust anyone who reaches out to you with a plan for how to spend your money.

The big lesson from all of these scams is to never trust anyone who reaches out to you, out of the blue, and claims to have spotted a problem you didn't see. It's always a scam. As folks are still falling for these scams, it's evidence that we still have work to do as far as getting the word out.

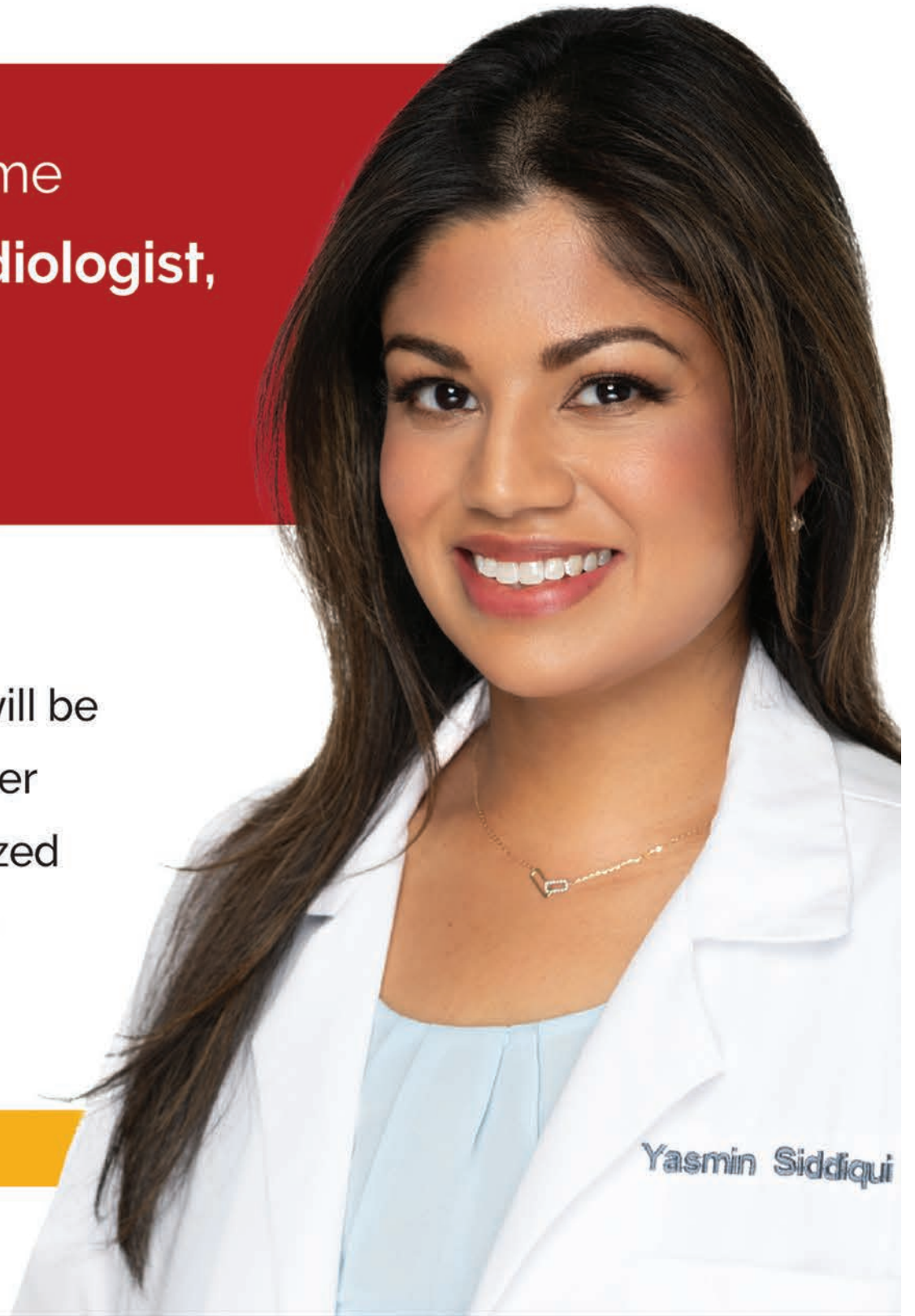

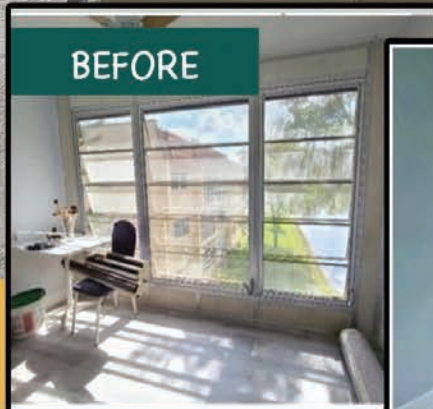

Don't Be Scammed—Get your COVID and Flu Shots ASAP

If a Nigerian Prince sent you an email with an offer of \$10 million if only you would send him your bank account information, would you do it? That scam is so old, it's now a joke. But the internet is full of newer scams and conspiracy theories that could cost you your health or even your life. Among the most harmful are those warning against the so-called "dangers" of COVID vaccines. If you are hesitant about getting your COVID and flu shots this year due to these warnings, you are being scammed.

We've come a long way since the COVID-19 virus spread around the world four years ago. Millions died, millions more got terribly sick, and hospitals were overwhelmed. Then the COVID vaccines became available. Social media was full of fake experts and political opportunists who spread scare stories—especially about the new mRNA vaccines. But billions of people were smart enough to reject those stories and an estimated 20 million lives were saved around the world in just the first year. Because the vaccines were very safe and effective, COVID deaths and hospitalizations declined so sharply that that most of us are not giving COVID much thought. But COVID is sadly still with us. People are still being hospitalized and dying with COVID—nowhere near the numbers of the pre-vaccine days—but in large numbers, nonetheless. Last year COVID was still in the top 10 leading causes of death in the U.S. and a surge of infections from the newer strains is expected in the coming months.

Chances are you had at least one, two or even three COVID vaccine shots early on. Unfortunately, the COVID virus, like the flu virus, changes over time. Natural mutations create new strains that reduce the immunity achieved by previous vaccinations or infection. Several newer strains of the "JN.1" lineage of the Omicron family of COVID viruses are circulating now, including the predominant KP.3.1.1. The earlier vaccines are not as effective against the newer strains and immunity from some vaccines and viral infections can fade over time. For older people (that's most of us at Wynmoor) immunity fades even faster. Several updated vaccines have been approved by the FDA and are available now at most major pharmacies. These vaccines are covered by Medicare, without any co-pay for most of us. While the vaccines may not prevent catching COVID, they greatly reduce the risk of serious symptoms,

hospitalizations, and death.

So-called "anti-vaxxers" are still spreading scare stories and conspiracy theories about the vaccines and that is nothing new. It is said that Ben Franklin regretted being influenced by the anti-vaxxers of his day and withheld an earlier form of inoculation from his son, who later died from smallpox. The first modern vaccine against smallpox was introduced in 1796, made from a mixture of cowpox and horsepox material (the word vaccine comes from the Latin "vacca" for cow). The smallpox vaccine was enormously successful and was made mandatory in most states in the U.S. in the 1800s. Nonetheless, anti-vaxxers were still fighting it in the Supreme Court as late as 1905. As smallpox vaccination became mandatory around the world, the disease that had been the worst killer humanity ever knew, was totally eliminated by 1979. Therefore, the smallpox vaccination is no longer needed. Polio vaccination in the 1950's was also enormously successful and polio too, was almost eliminated. However, polio has recently been found among unvaccinated people in the US and has reappeared internationally where vaccination programs were disrupted. Childhood scourges of measles, mumps and rubella were almost eliminated in the U.S. with the MMR vaccine. Anti-vaxxers targeted the MMR vaccine, especially after a report in the medical journal Lancet claimed an association of the vaccine with autism. That report, it turned out, was based on faked data by a single doctor. The Lancet eventually retracted the paper and Dr. Andrew Wakefield, who authored it, had his license revoked for fraud. Nonetheless, anti-vaxxers still peddle his false claims. Because some parents are withholding the MMR from their children, measles is reappearing in Florida and other states.

Anti-vaxxers have been proven wrong again and again, but they are loud and keep coming up with new versions, just like the Nigerian Prince scammers. They said more would die from the COVID vaccine than would die from COVID – wrong! They said that the drugs hydroxychloroquine (a malaria drug) and ivermectin (a parasite drug) would work against COVID –wrong! They said mRNA vaccines are untested and experimental –wrong! Serious side effects are, at most, about 1 in a million, much rarer than for most drugs we use every day.

Do the COVID vaccines have some side effects for some people? Of

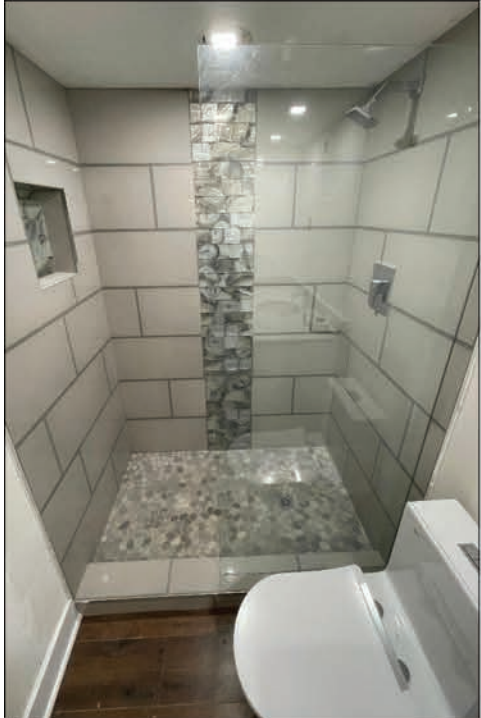

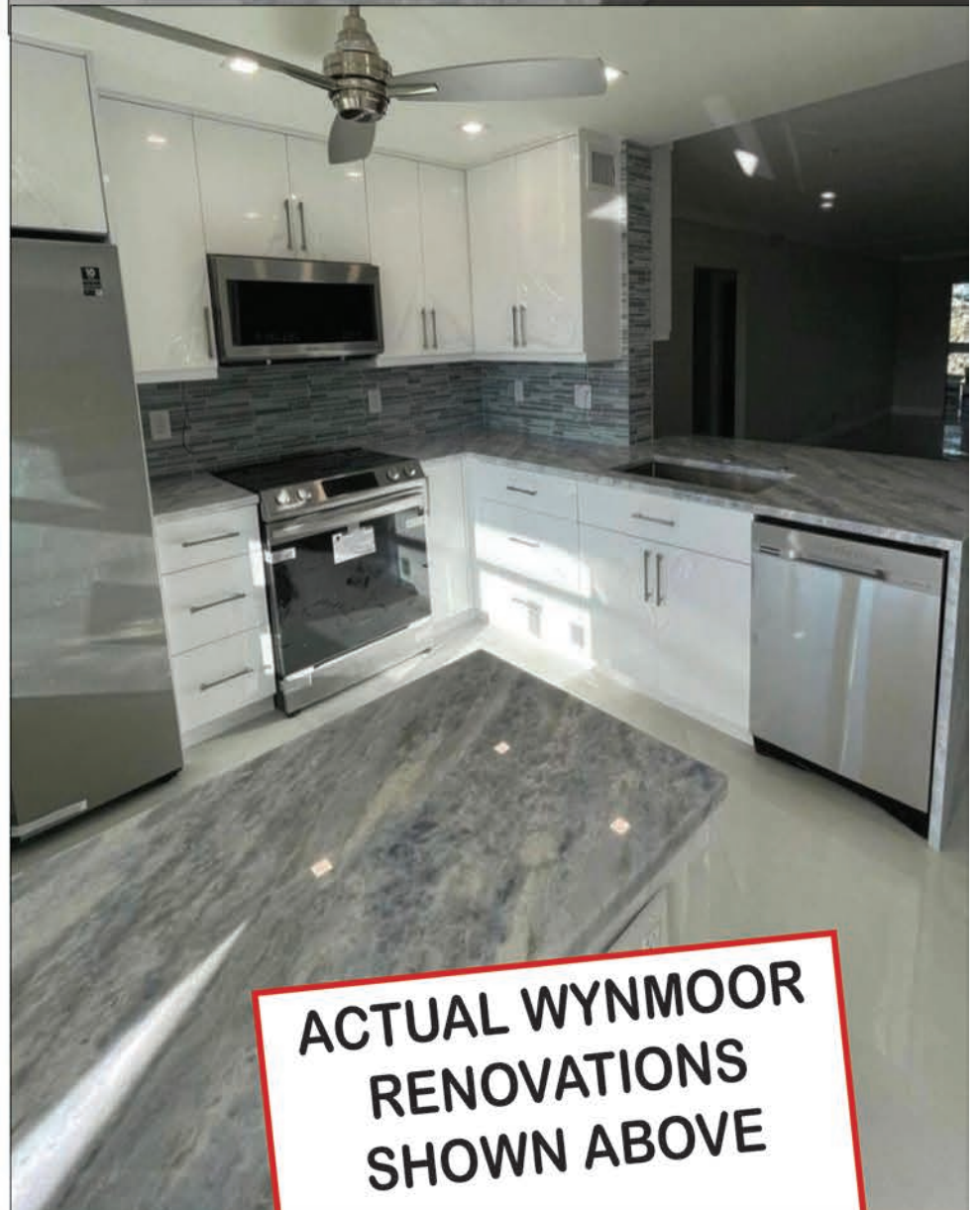

Florida law requires our office to assess all property based on the market data on January 1st of each year. We also grant tax-saving exemptions to qualified applicants. The Property Appraiser's Office does not set your tax rates, collect property taxes, or determine how the tax revenue is allocated by local government. The property tax bills are sent by the Broward County Tax Collector's Office. If you have questions regarding the payment of your tax bill, the Tax Collector's Office can be reached at 954-357-4829 or you can visit their website at <https://www.broward.org/RecordsTaxesTreasury>.

Where Is My 2025 Homestead Exemption?

The tax bill you received this month from the Broward County Tax Collector is for the 2024 tax year. If you acquired your home in 2024 and the previous owners of your new home lawfully received Homestead Exemption or any other exemption on January 1, 2024, you may have inherited their exemptions on your 2024 property tax bill. Florida Statutes require these 2024 exemptions be removed and the property be reassessed at the full Just/Market Value for 2025. This may result in an increase in your 2025 property taxes. It is important that

you apply for your own Homestead Exemption in your name if you believe you are eligible for 2025. Your new 2025 Homestead Exemption will be reflected next year on all 2025 property records, notices, and tax bills. Any pre-approved 2025 Homestead Exemptions will show online in late-December 2024. You can apply for Homestead Exemption and any other exemptions you may qualify for online at <https://web.bcpa.net/bcpaclient/#/HomesteadExemption>.

If you have questions regarding your Homestead or other tax-saving exemptions, please contact our Exemptions Department at 954-357-6830.

Quarterly Installment Payments

If you pay your property taxes through the Tax Collector's quarterly installment plan, any newly approved 2024 exemptions will be applied to the 3rd and 4th installment payment amounts. Any adjustments for 2024 are made on the final two quarterly 2024 installment tax bills in December 2024 and March 2025.

course! EVERY MEDICINE has some side effects for some people. Perhaps you are skeptical about the FDA science for approving drugs. Do you take any prescription pills for high blood pressure? Or high cholesterol? Or diabetes? Or antibiotics? Or any prescription medicine at all? The FDA scientific approval process, comparing benefits of effectiveness to the risks of side effects is the same for the vaccines as for the medicines you now take. If you trust your doctor and the FDA about those other pills, there is no reason to be hesitant about the COVID vaccines.

Professionally, I teach doctors to read study reports critically and with healthy skepticism, especially when something new comes out. But when the data are strong, as with COVID vaccine safety, it is wrong and harmful to let prejudice, politics or social media scare stories get in the way of strong evidence.

Save yourself and your loved ones unnecessary grief. Get a new COVID booster shot as soon as possible. You can get this year's flu vaccine at the same time. If you're 65 or over, ask for the stronger version of the flu shot. In the last flu season, there were tens of thousands of deaths and hundreds of thousands of hospitalizations from flu-related illness. And don't forget the RSV vaccine if you are over 60 and haven't gotten one already. If you did get an RSV shot, you do not have to renew it this year.

Not so long ago, some people campaigned against mandatory seat belts in cars. Some (foolish) people still don't buckle up. Vaccines are very much like seat belts. Seat belts don't prevent car accidents, but they have been proven to reduce injuries and save lives as do vaccines. Buckle up, roll up your sleeve and have a safer and healthier season.

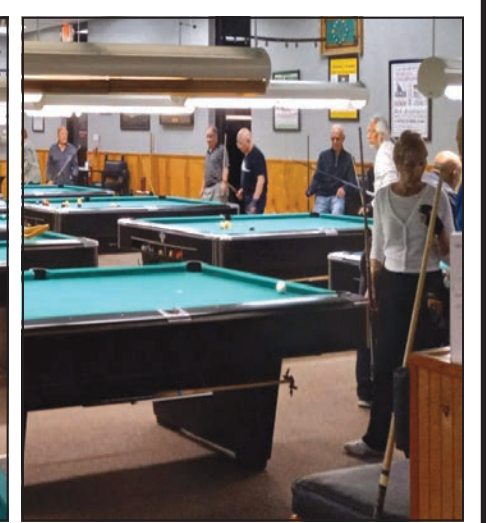

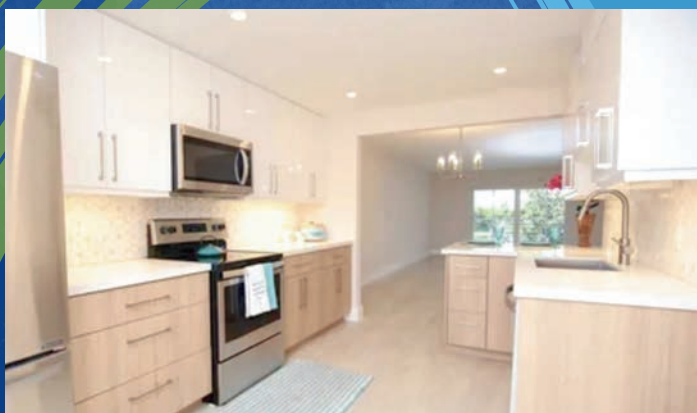

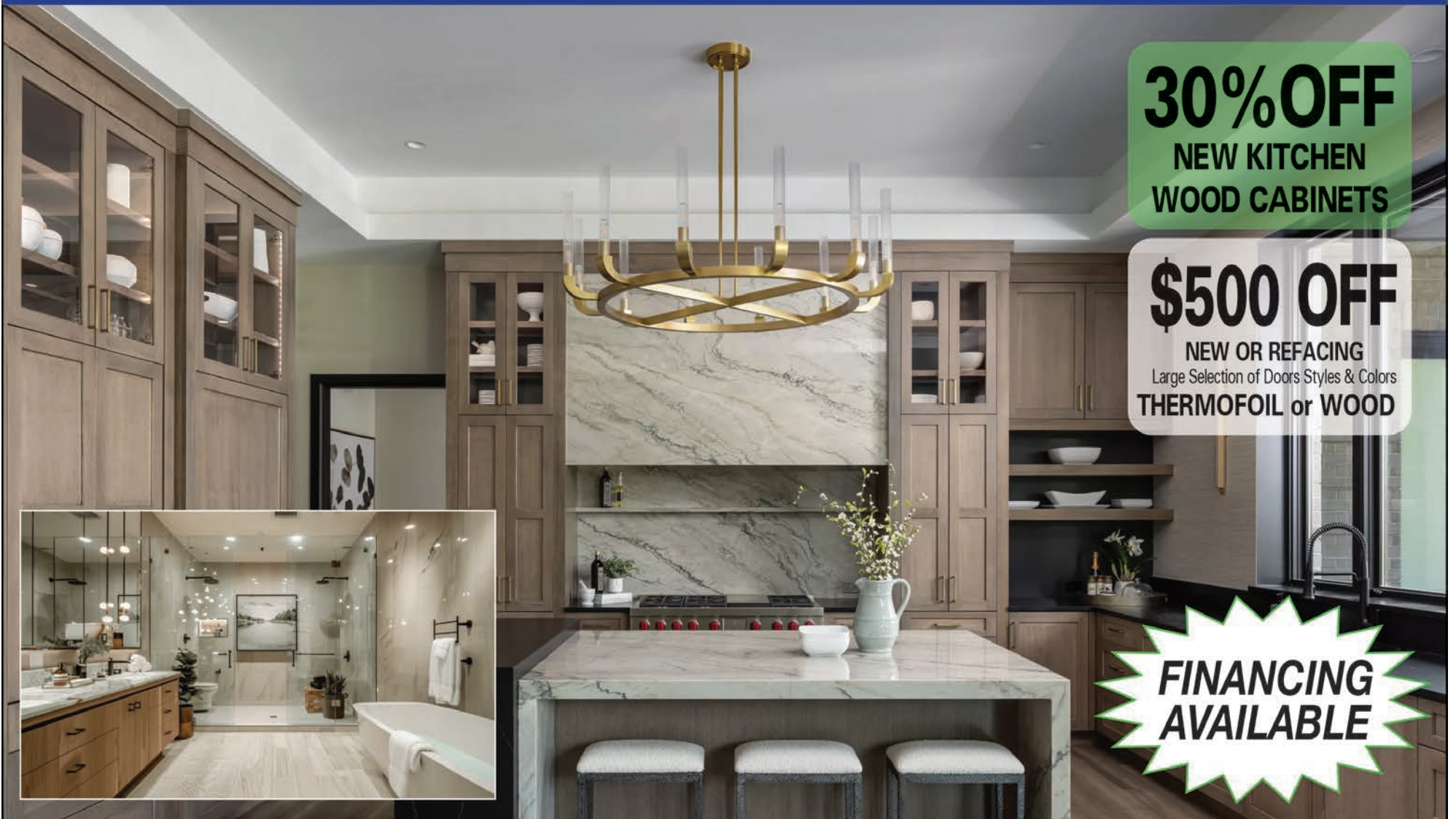

ASK DR. JOY

SELFISHNESS

This article is regarding a subject that just keeps coming up in my discussions with people. Selfishness. Actually, this will be in part a small excerpt from a chapter in my book.

Being unselfish has been pounded into us forever. We have been told since we were tiny tots that selfishness was bad, and we should avoid being that way. When we were children, it was often about sharing our precious possessions with another child. I remember when my first granddaughter was very young, and I was babysitting. If she had a friend coming over, I would advise her that anything she didn't want to share, she didn't have to but she would have to put it away somewhere and that anything left over was to be shared. It worked quite well. At least she never moved her entire toy room into her bedroom.

Of course, anyone telling you that you are being selfish usually means that you aren't doing what they want or giving them what they need. I have always found this rather amusing because it made me wonder just who was being selfish here. However, calling someone selfish is almost like cursing at them. This is so far from the way it really is and so many people are reluctant to understand and accept the true nature of what selfishness is. It is not about exploiting or taking advantage of anyone else. It is about taking care of ourselves. It is about understanding how much we matter. When you are questioning this or trying hard to be 'unselfish' you are in a state of inner conflict.

This is you trying to change yourself into something you were not meant to be. Once again, importantly, this does not mean or even insinuate, not caring about others or wanting them to give you whatever you want. That is not the definition of selfishness, it is the definition of narcissism.

I tell people I am selfish all the time. They really have no idea what I

am talking about, especially because I don't appear mean or narcissistic. Because I am neither. But I am definitely selfish. I can't help anyone if I don't take care of myself first. And I understand that means looking for ways for me to feel happier, more at peace and emotionally stronger. For me, it also means that I don't keep a balance sheet. If I need a favor from someone who can't do it, I recognize that they can't do it. I don't expect people to put my needs before their own. It doesn't matter how you want to take care of yourself or what is important to you. The idea is to maintain your good feelings and your equilibrium regardless of what is happening around you.

I actually like and prefer to be with similarly healthily selfish people. I remember my mentor, Nathaniel Branden, saying that no one wants the fruit of someone else's sacrifice. I loved hearing that. I want to know that the person who wants to be with me or even do something for me is doing it because it is giving them pleasure. I don't want to use them to serve myself at their expense nor do I want to be used so they can serve themselves. This does not preclude or negate my doing something for someone else because I want to, and it is a value to me to do so.

I hope this doesn't confuse anyone but you will most likely be able to tell why you want to be with someone and why someone wants to be with you, why you want to do something for someone and why they might be doing something for you. Your beliefs will be screaming at you to not be selfish and sacrifice your good feelings for the sake of those of another while your feelings are telling quite a different story.

Perhaps the first question to ask yourself is if you believe that you are supposed to be living your precious life for the well-being of someone else, not sometimes because you really want to, but at those times when you know you really don't want to but think you should. Difficult Personalities and How to Deal With Them

Narcissistic People - Part II

In the October 2024 issue, I provided definitions and examples of “Narcissistic People.” In this article, I will discuss how to recognize and deal with narcissistic abuse.

To review, narcissism can be observed on a continuum from healthy to pathological, with most people scoring near the middle, and some at either extreme. **Pathological narcissists** display a pervasive pattern of grandiosity, need for excessive admiration and attention, and lack of empathy. They exaggerate, overestimate, or inflate their abilities and accomplishments and are boastful and pretentious. They underestimate and devalue others and resent those who receive praise for real accomplishments. While they can at first appear charming, eventually they display arrogant, haughty, snobbish, disdainful, pretentious, or patronizing behaviors and attitudes.

Those with severe pathological narcissism can be diagnosed with Narcissistic Personality Disorder (NPD). Individuals with narcissistic traits or NPD may engage in **Narcissistic Abuse** in a relationship with a romantic partner, friend, boss, or co-worker. Narcissistic abuse can be incredibly difficult to endure, and victims can experience significant emotional distress, affecting their personal and professional lives. Not all people with narcissistic traits or NPD are abusers and not all narcissistic abusers have NPD. Regardless, a mental health diagnosis never excuses abusive behavior. People *choose* to abuse and manipulate others. Recognizing narcissist abuse is the first step towards dealing with it.

Signs of Narcissist Abuse

Love Bombing: During the initial love bombing phase, it’s not unusual for a narcissistic partner, friend, or family member to shower you with gushy compliments and expensive gifts to make you feel special and adored, to earn your trust and to eventually control you. Then, slowly sarcastic insults and criticisms begin to replace the gifts and declarations of love.

Gaslighting: It’s not unusual for a narcissistic abuser, when called out, to deny their hurtful and controlling behaviors towards you. They pretend they don’t remember or accuse you of lying or not understanding the way things “really” happened in order to make you doubt your perception of events and decision-making abilities.

Ignoring Boundaries: Narcissistic abusers have little respect for boundaries. They may react with anger, arguments, or accusations when you attempt to set healthy boundaries. They might read through your text messages, follow you around, or do other things that you’ve asked them not to do.

Projecting/Shifting Responsibility and Blame: Instead of accepting responsibility for mistakes, negative actions or harmful behaviors, narcissistic people may project or attribute their unacceptable feelings, impulses, or behaviors onto you. A common manipulative tactic is to deny, attack, and reverse the victim and offender roles through deceit or by getting angry to the point that you try to soothe them by apologizing and placing blame on yourself.

Nitpicking and Insults: A narcissistic abuser can make you feel like everything you do is wrong. Your appearance, behavior, and even the sound

of your voice might be criticized. Verbal abuse like name-calling and harsh criticism, are ways for those with NPD disorder to lower a victim’s self-esteem. Abusers will often try to disguise their abusive behavior as sarcasm or jokes.

Exploiting Emotional Vulnerabilities: A narcissistic abuser may use intimate knowledge or sensitive information shared in trust to manipulate or emotionally wound you. This exploitation can deepen your sense of dependency and weaken your ability to resist their control.

Withholding: People who are narcissists may withhold money, affection, or even communication (“the silent treatment”) in an attempt to punish their abuse victims.

Emotional Blackmail: When you don’t do what an abuser wants, they may play the victim, use threats and guilt-tripping to make you comply.

Malicious Gossip and Sabotage: Someone with NPD may deliberately spread lies about you and take steps to sabotage your career, relationships, or any other aspect of your life. Slander, lies, and damage to your reputation can all be ways to intentionally isolate you from others and keep you under their control.

Accusations: When you’re in a romantic relationship with a narcissistic person, they may accuse you of lying, stealing, cheating, or other negative behaviors. Being wrongfully accused can put you on the defensive, which can help deflect from the behaviors and actions of someone with NPD.

How to Deal with Narcissistic Abuse

Do Not React: Emotional reactions to abuse will energize the narcissist. Instead of letting the narcissist control the conversation, steer the conversation back to the issue at hand.

Avoid Direct Confrontation: Narcissists are hyper-sensitive to any kind of criticism. If you do need to give negative feedback, try to frame it as positive suggestions.

Insist on Action, Not Promises: Narcissists can promise grandiose fictional plans for the future. Remind them you value deeds, not promises.

Maintain Boundaries: Setting and maintaining boundaries involves determining what you are comfortable with, establishing limits, and then communicating and upholding these limits. For example, you can limit the time you spend with the person, decide which topics you’re willing to discuss, or set limits on the behaviors you’ll accept. They may respond with anger or try to make you feel guilty. Setting boundaries might feel uncomfortable initially but becomes easier over time.

Practicing Self-Care: Narcissists can drain your emotional energy, leaving you feeling exhausted, anxious, or depressed. It’s important to take care of yourself physically, emotionally, and mentally. This could involve regular exercise, maintaining a balanced diet, ensuring you get enough sleep, and taking time to engage in recreational activities.

Avoiding Personalization and Blame: You are not responsible for others’ faults, failures, emotions or problems, no matter how much they try to blame you. Recognizing abusive behavior as a manifestation of their disorder, doesn’t

Service Equals Reward

Using Technology to Enhance Public Safety Service

Technology plays a crucial role in safeguarding our community. To stay ahead, the Broward Sheriff's Office (BSO) continuously adopts innovative technological solutions to deliver the highest level of public safety services to Broward County. A recent example is the arrest of 12 students by our Threat Management Unit (TMU) at the start of the school year for making online threats. Using real-time social media monitoring, the TMU swiftly identified, investigated, and neutralized the threats, demonstrating the effectiveness of their advanced systems.

While this illustrates how technology enhances our ability to protect the community, BSO's proactive and evolving use of technology extends well beyond threat detection and response—it's a pivotal part of our organizational strategy. We consistently research and implement advanced tools to strengthen our overall response capabilities and safeguard our county. A few examples are highlighted below.

- The **BSO Digital Forensics Unit** has significantly boosted its technological capabilities by increasing storage capacity and accelerating data transfer, which speeds up processing time and allows our investigators to examine multiple devices simultaneously. These upgrades, alongside the unit's expansion, have resulted in substantial time savings, improved efficiency, and successful results in solving cases with critical digital information.

- The **BSO Training Division** is testing cutting-edge virtual reality (VR) systems to further augment our law enforcement training. This advanced technology allows for simultaneous training capabilities utilizing diverse scenarios, from de-escalation tactics to active shooter responses. It also supports the integration of detailed building plans, allowing deputies to train in specific environments, such as schools or courthouses. These VR systems will save time and reduce costs by



allowing more frequent and efficient training sessions, with the added benefit of video review for post-training analysis. A significant portion of the funding for these systems was secured through grants, and we anticipate rolling out introductory training in early 2025.

- The **BSO Real Time Crime Center (RTCC)** has incorporated new technology, including facial recognition and license plate reader software, to investigate, solve and prevent crimes. Recent technology upgrades have enhanced BSO's ability to identify vehicles and link them to suspects, victims or crimes and better utilize mobile cameras strategically deployed in crime hotspots.

- The **BSO Department of Fire Rescue and Emergency Services** has adopted the GlideScope, an advanced tool that uses video to help guide intubation. This technology provides our firefighter/paramedics with a clear view of a patient's airway, significantly improving the success of securing an airway on the first attempt, which can be lifesaving in critical situations. As of today, we have 22 GlideScopes in use across the county.

- The **BSO Crime Lab** has made significant technological improvements to its investigative capabilities. One such advancement is Y-STR technology, which isolates DNA to identify suspects. It also enables familial searching within the Combined DNA Index System (CODIS), providing leads in cases where traditional DNA analysis may fall short. The Crime Lab also uses the National Integrated Ballistic Information Network (NIBIN), a national database that allows us to compare fired cartridge cases and identify potential connections to other crimes.

As public safety needs evolve, BSO remains dedicated to implementing cutting-edge technologies that enhance our ability to identify, track, monitor and prevent crime. We will continue to expand our use of innovative tools to uphold our commitment to excellence in service.

mean you accept or condone it. Try to maintain a balanced perspective and separate yourself emotionally from the narcissist’s manipulations. Trusted friends, family members, or support groups can provide validation and reinforcement when things get tough.

Communicating Effectively: Be calm, clear, concise, and assertive. You may need to repeat your points multiple times and reinforce your boundaries consistently. Assertive communication is not about being aggressive or confrontational—it’s about expressing your needs and feelings in a respectful and direct way. Use “I” statements rather than “You” statements. For example, instead of saying “*You never listen to me,*” you could say, “*I feel unheard when I express my thoughts.*” This can reduce defensiveness and promote more constructive communication.

Practice Empathy without Enabling: Interacting with a narcissist can be a delicate balancing act. On one hand, it’s important to remember that some narcissists often act the way they do because of deep-seated insecurities and fears. Showing empathy can help diffuse tension and make your interactions smoother. On the other hand, it’s essential not to enable harmful behavior. You can show understanding and empathy for their feelings without allowing them to overstep your boundaries or manipulate you. It’s a tough balance to strike, but with practice, it’s possible to master.

Seeking Professional Help: Dealing with a narcissistic personality can be challenging and,

at times, distressing. If you are feeling trapped, overwhelmed, or questioning your self-worth, don’t hesitate to seek professional help. Therapists can provide invaluable support. There’s no shame in reaching out—taking care of your mental health is one of the best things you can do for yourself.

Know When It’s Time to Go: If you strongly believe the relationship is unhealthy and despite your best efforts the abuser will not change, it’s time to go. If your partner behaves violently, and engages in abuse – emotional, verbal, physical,

sexual –it’s time to leave. Ending a relationship is always difficult. You may still have love or affection for your partner, even if their NPD has hurt you. Don’t say you’re leaving unless you really mean it. Prepare beforehand and lay out clear reasons for leaving. Abusers, like addicts and alcoholics, may have a difficult time accepting your decision and will try repeatedly to pull you back in—begging and pleading with sincere-sounding, but empty promises to do better.

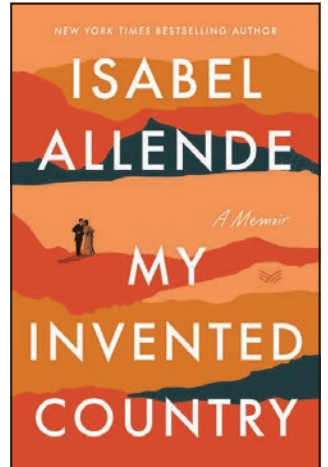

My Invented Country, A Memoir Isabel Allende

The author is a niece of Salvador Allende, the President of Chile who was assassinated when Augusto Pinochet seized power in a military coup in 1973. The Allendes were a prosperous extended family, well known in Santiago. Two years later Isobel was forced to emigrate, first to Venezuela, where her husband and children followed her. She began to write fiction, based on stories her grandfather had told her, becoming a best-selling author and eventually immigrating to California. The book is a love letter to her country, published in 2003. Her descriptions of Chilean society, customs, and beliefs are charming and humorous. She says that most of her many novels are based on family stories and her own experiences in her beloved home country. Her memoir inspires me to read a few of them.



The Second Stranger Martin Griffin

Remi Yorke has spent a decade interceding for and trying to rescue her younger brother from a life of crime in Scotland's underworld. When he lands in a remote prison she takes a job at a nearby hotel. After he dies in a prison riot she plans her departure from her dead-end job there. Her last night of employment is interrupted by the accident of a police convoy escorting the brother's old boss away from the prison. The book's three hundred pages cover the increasingly bizarre and deadly events of that frigid Scottish night. Almost nobody is who they seem to be, Scotland is delivering a fierce snowstorm, and Remi gradually learns more horrifying details about her brother's past. By the time I had struggled through the snow with her, dodging danger and dealing with shifting identities, I was exhausted by the plot shifts and fully in agreement with her wish to make it out of the ice and all the way to Chile, no matter what.



Last month we started a tutorial on Jewish Funeral customs. We are continuing with more information this month.

What happens at a Jewish cemetery? Prayers are said, the casket is lowered into the ground and covered with dirt. How and by whom the casket is covered varies by traditions. Superstition plays a big part. Maybe the ghost of the deceased could escape. Medical students could rob the grave, etc. I like to think that the finality of a covered grave starts the healing of the survivors.

There is a custom which began in Greece and Turkey that one uses the back side of a shovel to put in the first dirt, then shovels more dirt before dropping the shovel. It is not passed from person to person so as to not pass "bad vibes" with it. Whether the grave is filled by the mourners, or left for the cemetery workers to fill is up to the family.

Those in attendance often form two lines for the mourners to pass through when leaving the cemetery. Words of comfort are said.

Why is charity sometimes collected after the funeral? There is a saying from Proverbs that "Wealth is of no help on the day of tragedy, but charity saves from death."

Is it necessary to wash your hands upon leaving a cemetery? Yes and No. It depends on your particular tradition. But...if you do wash hands, do not pass the water container to someone else. Place it on the ground for the same reason as to not pass the shovel.

There are some rites of mourning that do not apply to an infant who has lived less than 30 days. The fetus is considered part of the mother's body until birth. For the first 30 days after birth, should the baby not survive, it is considered a nonviable fetus.

Can a mourner go to a wedding? If a child is getting married, the mourner may attend the ceremony, but not eat or listen to music-activities which cause joy.

As above, a mourner may go to work, if necessary, but not to social activities. If one must work in order to eat, or a doctor to save a patient, life comes first.

Must Jews visit the graves of departed relatives? There is no requirement that a grave be visited. Rather, visiting a grave may bring back pleasant memories of the deceased. Some Jews like to believe that visiting a grave will invoke the spirit of the deceased to intervene in the life of the living.

Why is the Yizkor prayer said on Yom Kippur? As mentioned earlier, much of Jewish tradition is based on superstition. Many early Jews believed that we all have sinned at some point in our lives. Yom Kippur is associated with the expiation of sins; therefore, Yizkor is said for loved ones so that their souls could enter Paradise. Sephardim generally do not say the Yizkor prayer.

Do Jews believe in an afterlife? Again, yes and no. In Numbers 16:33 Korach's people went down to live in She'ol-hell or hades. In the Book of Daniel, we read of everlasting life. Orthodox believe that Gog of Magog will be defeated by Israel, the Messiah will come, and the world will be at peace, with deserving Jewish dead reaching the Holy Land and be resurrected. Reform, Reconstructionist and most Conservative Jews believe that there is a soul which will survive. A whole article could be written on how Jews view a Messiah!

Is there a right way for Jews to mourn? As with all else in Jewish life-it depends.

Revocable Living Trust Important For Out Of State Property

Are you a snowbird just returning to Florida for the winter? Some of my clients have their homestead in Florida; others declare their legal residence in another state.

In either case, a Revocable Living Trust is very useful to avoid probate in both states. If you are a Florida resident, you can own your homestead property via a Revocable Living Trust without losing your homestead exemption. In addition, you are eliminating the need for probate when you pass away. You can also transfer real estate owned in any other state to your Florida Trust. Generally, a Florida lawyer will prepare the Revocable Living Trust and Quit Claim Deed to transfer the Florida property into the Trust. If you are a Florida resident, the lawyer will also prepare a new Florida Last Will and Testament called a Pourover Will. This provides for the transfer to your Trust upon your death of any other assets not in the Trust or which do not have beneficiaries already designated. It is a security blanket to cover any assets payable to your Estate. For example, if you were killed in a car accident due to the negligence of another driver, your Personal Representative would be able to settle your Estate's wrongful death claim and "pourover" the proceeds into your Trust.

If you are not a Florida resident, you can still create a Revocable Living Trust and execute a Quit Claim Deed to put your Florida property into the Trust. Your Last Will and Testament will be done by a lawyer in the state in which you have your legal residence. In addition, that lawyer can prepare



a Deed to transfer the out of state property into the Florida Trust. You can also do the Trust in your state of residence and have a Florida lawyer transfer your Florida property to that Trust.

Another favorable factor in creating a Revocable Living Trust is that you can always amend the Trust without having to change the Deed. In addition, once you create the Trust, you can always buy new properties in any state in the name of the Trust.

The Revocable Living Trust is recommended by most lawyers over a Deed which includes names of other persons. Once another person's name is on your Deed, there are potential risks to you and your

property. These include the possibility that the other person may undergo a divorce, bankruptcy, have a judgment against them, or die before you or with you in a common accident. It may also affect your homestead exemption. All of these risks should be discussed with your attorney before deciding to put someone else's name on your Deed. By contrast, the Revocable Living Trust eliminates those risks since no other name is on the Deed. You simply transfer it from yourself to yourself as Trustee of your Trust.

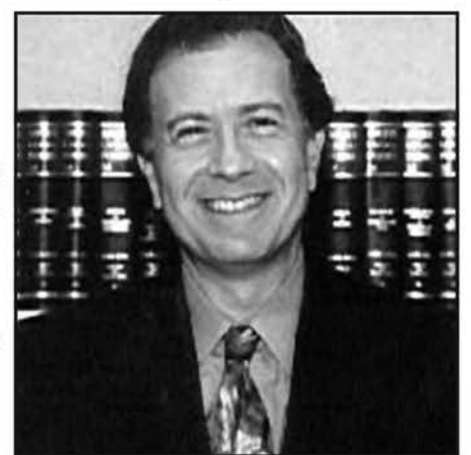

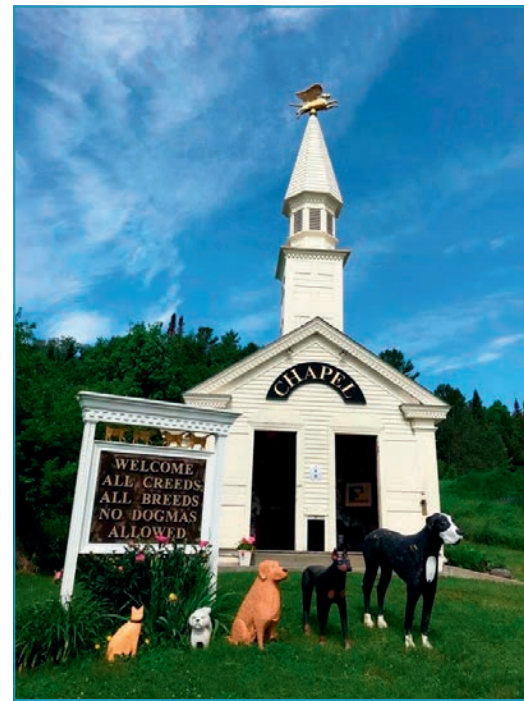

It is the home of the Stephen Huneck Dog Chapel and Art Gallery. I did not visit the Stephen Huneck Art Gallery, because I arrived in the late afternoon. Albeit, I visited the Dog Chapel dedicated to the love of dogs and the joy they bring to so many people.

The late Stephen Huneck was an author of children's books and a masterful woodcarver. Stephen Huneck was a prominent 20th and early 21st Century American Folk Artist. Stephen Huneck lived in Vermont's Northeast Kingdom. I went to college and graduated college in Vermont's Northeast Kingdom, a somewhat remote part of New England.

This was my first visit to Dog Mountain where dogs are free to run, play, and meet other dogs. Usually, when I am in Saint Johnsbury, I visit the Saint Johnsbury Athenaeum, a Victorian Style Library with a nice small art museum featuring quality paintings by Albert Bierstadt "Domes of Yosemite," Louis Pinel de Grandchamp "Donkey Driver of Cairo," the exemplar of quality Orientalism and William Adolphe Bougereau "Raspberry Girl,"

The Dog Chapel has stain glass windows memorializing dogs. It has pews with delightful carvings of Golden Retrievers and Labrador Retrievers along the sides of the pews. It has a plethora of notes dedicated to people's beloved dogs that have passed away in the front of the Dog Chapel. The exterior of Dog Chapel resembles a small quintessential Northeast Kingdom Congregationalist Church. Stephen Huneck, the creator of Dog Mountain and Dog Chapel loved his dog, Sally, a Black Labrador Retriever.

After visiting the Dog Chapel, I walked along its trails on top of the small mountain for about two miles enjoying the Northeast Kingdom Flora. Sometimes, I was followed by friendly dogs of different breeds on my walk. I felt like the Pied Piper. If and when you visit the Northeast Kingdom and Saint Johnsbury, the principal town in Caledonia County, I recommend this unique activity. Currently, Dog Mountain and the Dog Chapel are open again. It was closed in July, due to flood and storm damage.

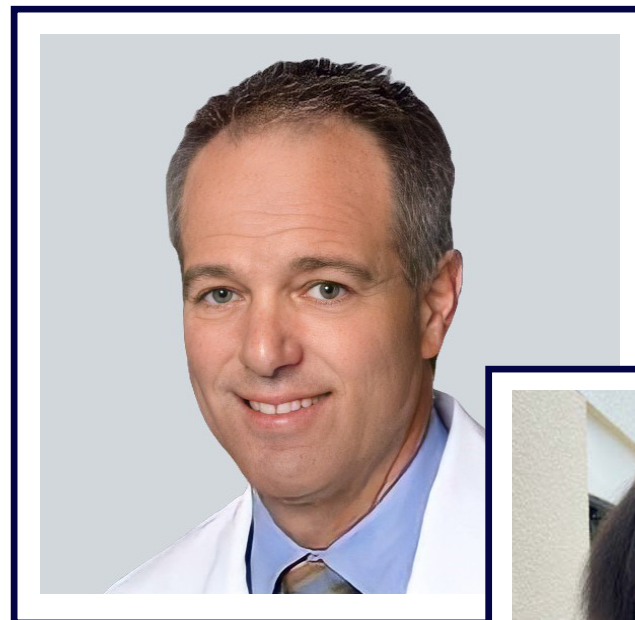

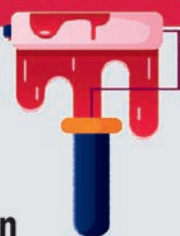

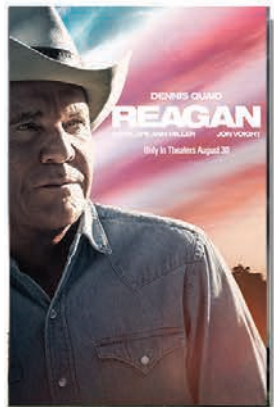

WOODSHOP

The Woodshop Planning Committee is stocking up for the next bi-annual White Elephant Sale. The following are examples of what will be offered.

1. Mini and midi -bread, baguette, and bagel boards, and minnow shape cutting boards.

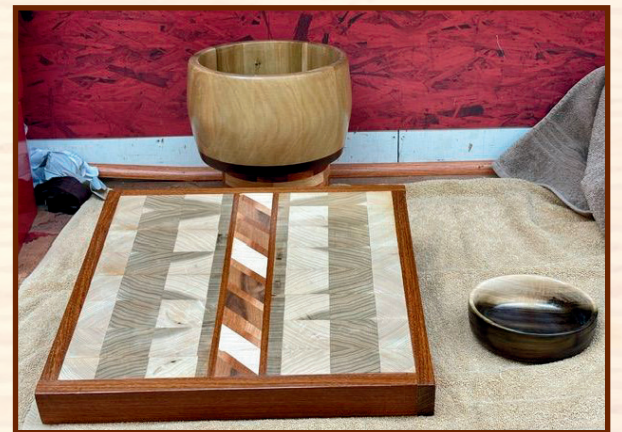
October is Superbowl Month at the Woodshop. The members proudly present to you the fruits of their combined efforts in this month's publication.

2. Here, Everett Yankie has captured the true essence of wood carving by marrying functionality with elegance. Yank wrapped two black cherry table lamps with dogwood flowers and serpentine vines that appear to ascend up an imaginary staircase with style and grace. The Tiffany-stained glass canopy is reminiscent of bygone elegance. Yank sculptured this 12" black cherry bowl and decided to inlay a turquoise hummingbird in the base for accent.



3. This olive wood jewelry box contains two drawers with dividers that are covered with maroon swede. Note the use again of the turquoise inlay in the top cover. To the left and right of the chest are two other impressive creations, a shallow dish and a deep bowl both turned from the same olive wood used in the box. Front left and right are two examples of unfinished olive wood lumber with their natural fawn and cream color. Olive wood possesses a wild grain and is much sought after for its ability to produce a deep radiant lustre.

4. The Poplar tree was selected for the next presentation. Finished dimensional poplar lumber is characterized by earthy, creamy, honeydew green overtones, with occasional flashes of dark gray. First, we have a 12" tulip shape bowl turned from 3" stock, sitting atop a Brazilian cherry base. Next is a 18"x 18" end grain cutting block/board. Note the creative placement of the peaks and tri-color chevron stripe down the center surrounded by a Honduran Mahogany border.



5. If you're wondering where the 40' mahogany tree near the Pickle Ball courts disappeared to, well visit the Woodshop and meet The Curator of Precision and Excellence. Karl Georgi selected the limbs rather than the trunk so he could capture the rich creamy early wood color rather than the amber. Karl has turned 2 large vases and several salt vaults all with covers. Karl is a skilled Artison who incorporates traditional techniques to create one-of-a-kind masterpieces.

6. The woods incorporated in the creation of the next presentation of bowls are all indigenous to North America. Top left: Vancouver red cedar with shafts of sunlight encompassing the top rim, 2&3, simplistic assorted pillars of hard woods molded together into a tulip shape. Front: Ennio Ruggi has turned the shallow dishes and plates in the front row from the following species found in the New York's Hudson Valley, sassafras, spaulded maple, sycamore and ambrosia. The centerpiece of this outstanding assortment is a stairway to a lover's heart. The creator has transformed ordinary wood waves of romance into a captivating treasure for a very special Valentine. Hopefully hinting of a whisper of candlelight and clicking crystal.



Dave Norcross and Ernie Fleury have elevated their talents. Each of the 6 bowls possesses its own vibrant design element and comes with its own unique story. The primary wood used is South African Gabon Padauk for its vibrant color dispersion. The 6 bowls are displayed from their front and top views. Each row contains 12 segments cleverly positioned for optimal eye appeal and layered radiance. LtoR: The top views color dispersion swing from sunset, herringbone, chevron, tranquil, swirly, untamed, and cascading.



The Woodshop believes that wood is an artform whose goal is to inspire and educate others who share our passion.

FYI - Moss is a relatively harmless flowering non-parasite plant called an Epiphyte. It has no roots but absorbs nutrients from water and air and is spread by the wind. It seems to favor trees such as Live Oak which have lateral limbs from which to cling to.

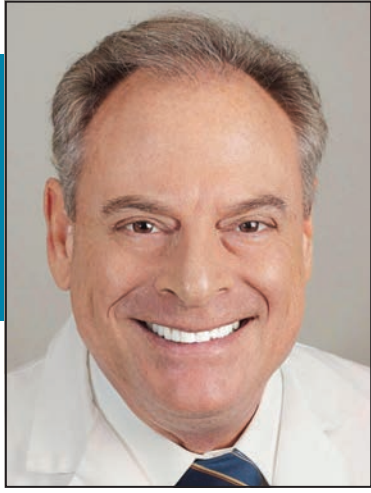

What is QiGong and Why Should I Care? Part II- A Step-by-Step Guide

Last month I briefly described the ancient Chinese art of Qigong and how it can benefit one's physical and mental health and wellbeing.

What follows is guided instruction of a simple yet very powerful introductory QiGong routine. It is entirely safe and appropriate for anyone, regardless of age or current health issues. This routine is best done standing. If it is difficult for you to stand during this practice, it may be done sitting in a supportive chair or a stool which allows you to place both feet flat on the floor with knees and hips at 90° angles. If in a chair, you will need to sit forward so that your back is self-supporting. As it will be necessary to move your arms without hinderance, the chair you choose should not have arm rests. If you have difficulty raising or moving your arms, only do what you can without pain. Your intention will compensate for any lack of mobility.

Consistency Is Key: Even a few minutes daily can have significant benefits. Aim to practice QiGong regularly, either in the morning to boost energy or in the evening to relax and wind down.

Move with Intention: Pay attention to every movement, ensuring that it is slow, deliberate, and mindful.

Stay Present: Let go of any distractions or thoughts. Focus on your breath, your movements, and the flow of energy within your body.

Find a Quiet Space: A peaceful, open area is ideal. You can practice indoors or in nature, but the space should feel calming and undistracting.

Wear Loose Clothing: Choose clothes that allow free movement and do not restrict your limbs or torso.

Set an Intention: QiGong is a meditative practice, so setting an intention (such as cultivating relaxation or improving energy flow) can enhance the practice.

Step-by-Step Guide to QiGong Practice

1. Wuji Posture (Standing Meditation)

The first step in QiGong practice is standing still in the Wuji posture. This posture helps to center the body and mind.

How to Do It:

Stand with your feet shoulder-width apart, toes pointing forward.

Bend your knees slightly, unlocking them so you feel soft but stable.

Your arms hang naturally by your sides, fingers slightly curved, as if holding a small ball in each hand.

Keep your head lifted as if a string is pulling you up from the crown, elongating your spine.

Tuck in your chin slightly and focus on standing tall but relaxed.

Breathing: Inhale deeply through your nose, expanding your abdomen (diaphragmatic breathing). Exhale slowly through your mouth. Breathe rhythmically but without force.

Focus: Close your eyes and focus on your breath. Feel the weight of your body grounding into the earth through your feet. Allow tension to melt away with each exhale.

2. Heaven and Earth Connection (Raising the Sky)

This movement opens the body to energy from the heavens and grounds it to the earth. It stretches the spine and promotes energy flow.

How to Do It:

From the Wuji posture, inhale deeply and slowly raise both arms up from your sides. As your arms move upward, let your palms face the sky.

Once your arms are fully extended above your head, imagine you are pressing the sky upward.

As you exhale, slowly lower your arms down in front of you, palms facing the earth.

Repeat this motion 5-10 times, visualizing energy flowing from the heavens into your body as you raise your arms, and from your body into the earth as you lower them.

Focus: Imagine a flow of pure, vibrant energy descending from the sky into your body, nourishing your mind and organs. As your arms lower, feel the energy connecting you to the earth, grounding you.

3. Gathering Qi (Energy Ball)

This movement is about collecting Qi from the environment and storing it in your energy center, known as the Dantian.

How to Do It:

Stand in the Wuji posture. Slowly raise your arms to shoulder height with your elbows slightly bent and your palms facing inward toward each other, as though you are holding an invisible ball of energy between your hands.

As you inhale, feel the ball expand slightly; as you exhale, feel the ball gently contract. After 9 complete breaths bring your hands down to your lower abdomen just below the navel (Dantian), one hand placed over the other, to "store" the Qi there. Take a few moments in this posture to "store" the Qi.

Repeat this 9-breath procedure 2 more times.

Breathing: Inhale deeply through your nose as the ball expands; exhale softly through your mouth as it contracts.

Focus: Concentrate on feeling the warmth or tingling sensation in your hands, visualizing this energy ball growing and becoming more radiant as you breathe.

4. Closing the Practice

Closing QiGong is essential to settle the energy in your body and complete the practice.

How to Do It:

Return to the Wuji posture and take a few deep breaths, allowing your body to settle.

Rub your hands together vigorously to generate warmth.

Place your warmed hands over your lower abdomen (Dantian) and take three deep breaths, visualizing the Qi you've cultivated being stored safely in your body.

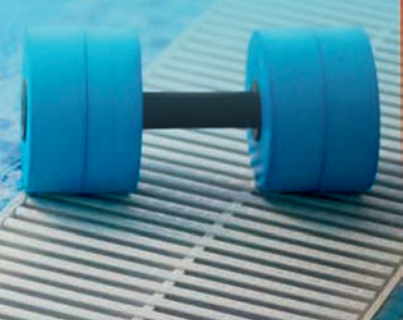
